INVITATION TO BID FOR THE PROCUREMENT OF

The Housing and Land Use Regulatory Board-Southern Mindanao Region (HLURB-SMR), intends to apply the sum of Eight Hundred Thousand Pesos (P800,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply and delivery of the following:

Bids received for each lot in excess of the excess of the corresponding ABC will be automatically rejected at bid opening. All bids shall be inclusive of all prevailing taxes and all other charges.

The HLURB-SMR now invites all proponents with at least five (5) years of continuous business operation as legitimate laptops and desktops suppliers to apply for eligibility and to bid for the contract for laptops and desktops. Bidders should have at least completed two (2) contracts similar to this projects within a period of two (2) years from the date of receipt of their bids.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information at the address given below starting April 6, 2015 from 8:30 AM to 4:30 PM. A complete set of Bidding Documents may be purchased by interested bidders from April 6 to April 14, 2015 upon payment of non-refundable of One Thousand Pesos Only (P1,000.00).

Bids must be delivered on or before 10:00 AM of April 15, 2015 at HLURB SMR, 2/F CAM Building, Monteverde St., Davao City. All bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulations of RA 9184.

Bid opening shall be on April 15, 2015 at 10:30 in the morning at the HLURB SMR Conference Room, 2/F CAM Building, Monteverde St., Davao City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The HLURB-SMR-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
