WHEREAS, in a letter dated 06 October 2008, the Hon. Vincent "Bingbong" P. Crisologo charged Mr. Jesse A. Obligation and Atty. Dunstan T. San Vicente, NCR Regional Officer and Housing and Land Use Arbiter respectively, of grave abuse in the performance of their official functions with respect to HLURB Case entitled Rolando Navarro vs. Celso Reyes, et al, by issuing "orders that are contrary to law and outside their jurisdiction" and "under irregular circumstances that merit the imposition of disciplinary measures";

WHEREAS, there is a need to conduct a comprehensive and impartial investigation and take any and all action with respect to the said charges, which lead to the reassignment of the above-named HLURB personnel;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED CONSTITUTING** a Board Committee to investigate Messrs. Jesse A. Obligation and Dunstan San Vicente with respect to the said charges and impose appropriate sanctions thereto;


RESOLVED, further that the Board Committee shall be composed of the following members:

HLURB Commissioner Arturo M. Dublado - Member



RESOLVED further that the Chairman is given complete control, power and authority over the conduct of the investigation and may call on HLURB personnel for assistance.




