AND ARBITERS CROSS-POSTING (TOUR OF DUTY)**


WHEREAS, the Board has approved the Policy on Regional Officers and Arbiters Cross Posting (Tour of Duty) covering a period of three (3) years;

WHEREAS, in a Special Board Meeting called for the purpose, the Board had decided on the following Regional Officers' Assignment, to wit:




