**APPROVING THE REQUEST FOR CALAMITY ASSISTANCE
TO ALL AFFECTED HLURB OFFICIALS AND EMPLOYEES**

WHEREAS, President Gloria Macapagal Arroyo issued Proclamation No. 1898, "Declaring A State Of National Calamity" in view of the unprecedented rains and floods caused by typhoon "Ondoy" that has brought incalculable devastations in the lives and properties of the Filipinos; and the further havoc wreaked by typhoon "Pepeng";


WHEREAS, the Civil Service Commission (CSC) issued Memorandum Circular No. 29, S. 2009, mandating "ALL HEADS OF xxx, AGENCIES OF THE NATIONAL GOVERNMENT; xxx", to render "Assistance to Victims of Typhoon Ondoy", and directing all heads of offices to marshal efforts and resources to help government employees;

WHEREAS, the Alliance of Key Shelter Agencies (KSAs) Employees Union, of which AHEAD (Association of HLURB Employees for Advancement and Development) is a member, has urgently requested the Office of the Vice-President (OVP) & HUDCC Chairman, the Honorable Noli L. De Castro for the grant of Calamity Assistance to all KSAs' employees; and the OVP, in a Memorandum dated 08 October 2009, favorably endorsed the said request to the respective heads of the KSAs, for appropriate action and disposition;

WHEREFORE, recognizing the tremendous damage to lives and properties and massive displacements caused by typhoon "Ondoy" and the hazards and devastations brought by typhoon "Pepeng," the grant of Calamity Assistance to all affected HLURB Officials and Employees is hereby **GRANTED**.
