## HOUSING AND LAND USE REGULATORY BOARD

**RESOLUTION NO. 865**  
Series of 2010

**AUTHORIZING THE BOARD TO DIRECTLY UTILIZE THE AMOUNT OF ELEVEN MILLION PESOS (Php11,000,000.00) FROM HLURB INCOME TO DEFRAY THE COST OF TRAININGS, SEMINARS, PURCHASE OF SUPPLIES AND OTHER OPERATING EXPENSES NOT COVERED OR FUNDED BY THE GENERAL APPROPRIATIONS ACT**

**WHEREAS**, during the previous meeting, it was agreed that management must conduct trainings, workshops and seminars in order to expedite the resolution of pending cases as well as to capacitate the professional and technical staff in meeting the mandates of the Board to the public;

**WHEREAS**, based on the approved budget of the Board, the funds allocated for trainings amounted only to P708,000.00 for the whole year, and for supplies covering the requirements both for Central and Regional Field Offices amounted only to P5,989,000.00;

**WHEREAS**, in the report submitted by management, it appears that the estimated costs of trainings, seminars and purchase of supplies needed to meet the policy directions of the Board would amount to Eleven Million Pesos (Php11,000,000.00), thus, the budget of the Board would be insufficient to fund these activities;


**WHEREAS**, Section 9 of Executive Order No. 648, Series of 1981, as amended by Executive Order No. 90, Series of 1986, authorizes this Board to directly utilize its income generated from fees, fines, charges and other collections in the performance of its functions to defray operating expenses and provide allowances to its personnel;

**WHEREAS**, based on the records of the Board, the current service income derived from fees, fines, charges and collections from licensing and its other functions are sufficient to cover not only the requested funds for trainings and supplies but also the requisite remittance to the Bureau of Treasury;


**WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to AUTHORIZE** the management to directly utilize the amount of Eleven Million Pesos (P11,000,000.00) chargeable against the service income of the Board to fund the various trainings, seminars and purchase of supplies and other operating expenses not funded by the General Appropriations Act, subject to availability of funds and existing accounting and auditing rules and regulations.
