**WHEREAS**, the Board is empowered under Letter of Instruction No. 729, Executive Order (EO) No. 648 Series of 1981 as amended by Executive Order No. 90 Series of 1986, Republic Act No. 7279, and Republic Act 7160, the Local Government Code as implemented by Executive Order No. 72 Series of 1991 to review and ratify the Provincial Physical Framework Plan of Provinces;

**WHEREAS**, the Province of Nueva Vizcaya has completed the formulation of its Provincial Physical Framework Plan through the Provincial Development Council and the Provincial Planning and Development Office;

**WHEREAS**, the combined Provincial Development Plan and Provincial Physical Framework Plan of the Province were approved by the Sangguniang Panlalawigan through Resolution No. 2010-926 entitled Resolution Approving the Nueva Vizcaya Provincial Development and Physical Framework Plan for the Period 2007-2013;

**WHEREAS**, the Province of Nueva Vizcaya has complied with the prescribed procedural and documentary requirements in the formulation of Provincial Physical Framework Plans;


**WHEREAS**, after a review of the submitted plan documents pursuant to the Review and Approval Process provided under HLURB Board Resolution No. 762 Series of 2004, the Board finds the Provincial Physical Framework Plan of the Province of Nueva Vizcaya substantially complies with national standards and guidelines on Provincial Physical Framework Plan formulation;
