## HOUSING AND LAND USE REGULATORY BOARD

### RESOLUTION NO. 883 Series of 2011

#### **AUTHORIZING THE BOARD TO DIRECTLY UTILIZE ITS SERVICE INCOME TO DEFRAY THE COST OF OPERATING EXPENSES RELATIVE TO PLANNING, REGULATION, ADJUDICATION, CAPABILITY BUILDING, STAFF DEVELOPMENT AND IMPROVEMENT OF WORK ENVIRONMENT NOT COVERED OR FUNDED BY THE GENERAL APPROPRIATIONS ACT**

**WHEREAS**, the Board has embarked on several programs, under its three major mandates, to pursue the directions and policies adopted to implement the national shelter program under the present administration, namely: 1) Planning - CLUP Zero Backlog; 2) Regulation - Full Implementation of RA 9904 and ISO Certification of HLURB's Licensing Function; 3) Adjudication - Strict enforcement of the HLURB 2011 Revised Rules of Procedure;

**WHEREAS**, to accomplish the said programs there is a need to provide technical assistance to targeted LGUs through cluster approach; provide additional capability-building and administrative support as well as capacitate the professional and technical staff in meeting the mandates of the Board to the public;

**WHEREAS**, the estimated cost of technical assistance to targeted LGUs through cluster approach; costs of trainings, seminars, hiring of HOA personnel, programmers and encoders as well as purchase of supplies needed to meet the policy directions of the Board would amount to Sixty One Million Pesos (P61,000,000.00) not funded under the General Appropriations Act;

**WHEREAS**, there is a need to augment the approved budget of the Board for trainings and supplies and other operating expenses considering that the funds allocated for trainings, which amounted only to Seven Hundred Eight Thousand Pesos (P708,000.00), for CY2011, and for supplies covering the requirements both for Central and Regional Field Offices, which amounted only to Six Million One Hundred Twenty Seven Thousand Pesos (P6,127,000.00) have already been depleted;

**WHEREAS**, Section 9 of Executive Order No. 648, Series of 1981, as amended by Executive Order No. 90, Series of 1986, authorizes this Board to directly utilize its income generated from fees, fines, charges and other collections in the performance of its functions to defray operating expenses and provide allowances to its personnel;


**WHEREAS**, based on the records of the Board, the current service income derived from fees, fines, charges and collections from licensing and its other functions are sufficient to cover not only the requested funds but also the requisite remittance to the Bureau of Treasury;

**WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to AUTHORIZE** management to directly utilize HLURB service income to defray the cost of operating expenses needed to meet the policy directions of the Board relative to Planning, Regulation, Adjudication, Capability building, staff development and improvement of work environment in the total amount of Sixty-One Million Pesos (P61,000,000.00), broken down as follows: **Planning** – Twenty-Four Million Pesos (P24,000,000.00); **Regulation** – Twenty Million Pesos (P20,000,000.00); **Adjudication** – Six Million Pesos (P6,000,000.00) and **Capability Building , Staff Development and Improvement of Work Environment** – Eleven Million Pesos (P11,000,000.00), not funded by the General Appropriations Act and subject to availability of funds and existing accounting and auditing rules and regulations.


