**APPROVING THE PROVINCIAL PHYSICAL FRAMEWORK  
PLAN (PPFP) OF THE PROVINCE OF ILOCOS SUR  
2010-2020**

WHEREAS, the Board is empowered under Letter of Instruction No. 729, Executive Order No. 648 Series of 1981 as amended by Executive Order No. 90 Series of 1986, Republic Act No. 7279, and Republic Act No. 7160, the Local Government Code as implemented by Executive Order No. 72 Series of 1991 to review and ratify the Provincial Physical Framework Plan of Provinces;

WHEREAS, the Province of Ilocos Sur has completed the formulation of its Provincial Physical Framework Plan through the Provincial Development Council and the Provincial Planning and Development Office;

WHEREAS, the Provincial Physical Framework Plan, which embodied the desired development thrusts of the province shall guide and set the direction of development and provide guidance to its component local government units in the preparation of their respective Comprehensive Land Use Plans;

WHEREAS, the Regional Land Use Committee, an inter-agency committee, reviewed the said PPFP and recommended its adoption and approval by the Sangguniang Panlalawigan through Resolution No. 02 Series of 2012;

WHEREAS, the combined Provincial Development Plan and Provincial Physical Framework Plan of the Province was approved by the Sangguniang Panlalawigan through Resolution No. 92 Series of 2012 titled *A Resolution Approving and Adopting the Enhanced 10-Year Indicative Provincial Development and Physical Framework Plan of Ilocos Sur*;

WHEREAS, the Province of Ilocos Sur has complied with the prescribed procedural and documentary requirements in the formulation of Provincial Physical Framework Plans;


WHEREAS, after a review of the submitted plan documents pursuant to the Review and Approval Process provided under HLURB Board Resolution No. 762, Series of 2004, the Board finds the Provincial Physical Framework Plan of the Province of Ilocos Sur as having complied with national guidelines on the formulation of Provincial Physical Framework Plans;


