BOARD RESOLUTION NO. 903

Series of 2013

APPROVING THE REQUEST FOR EXTENSION OF PERIOD TO USE THE BALANCE OF FUNDS APPROVED UNDER BOARD RESOLUTION NO. 883, S. 2011 TO DEFRAY THE COST OF OPERATING EXPENSES RELATIVE TO THE FULL IMPLEMENTATION OF THE 2013 CLUP ZERO BACKLOG PROGRAM NOT COVERED OR FUNDED BY THE GENERAL APPROPRIATIONS ACT

WHEREAS, the Housing and Land Use Regulatory Board (HLURB) was authorized under Board Resolution No. 883, Series of 2011 to directly utilize its service income to defray the cost of operating expenses with respect to several programs, under its three major mandates, namely: Planning, Regulation and Adjudication not funded by the General Appropriations Act and subject to availability of funds and existing accounting and auditing rules and regulations;

WHEREAS, one of the projects authorized to be funded by the aforementioned Board Resolution in the amount of Twenty-Four Million Pesos (P24,000,000.00) is the 2013 Zero Backlog Program, which aims to provide assistance (cluster approach) to One Thousand One Hundred Thirty Two (1,132) local government units (LGUs) in the preparation, review and approval of Comprehensive Land Use Plans and Zoning Ordinances (CLUPs/ZOs) targeted to be accomplished by end of May 2013;

WHEREAS, out of the One Thousand One Hundred Thirty Two (1,132) local government units (LGUs), HLURB had provided assistance to a total of One Thousand and Fifty Nine (1,059) LGUs whose CLUPs/ZOs are now in various stages of plan finalization, adoption and approval and had utilized the amount of approximately Sixteen Million One Hundred Thirty Five Thousand Pesos (P16,135,000.00) out of the Twenty-Four Million Pesos (P24,000,000.00) approved under Board Resolution No. 883, S. 2011, leaving a balance of approximately Seven Million Eight Hundred Sixty Five Thousand Pesos (P7,865,000.00);


WHEREAS, there is a need to utilize the balance of the previously approved funds for the continuation and accomplishment of the aforesaid identified activities until December 31, 2013, particularly the following, namely: a. conduct of cluster and modular workshops for target LGUs who were not able to join the 2012 cluster planning activities and LGUs targeted for 2013 planning assistance; and b. monitoring of CLUPs/ZOs for finalization by LGUs and the approval/adoption by their respective Sangguniang Bayan, Sangguniang Panlungsod and Sangguniang Panlalawigan or the HLURB;

Approving the Request for Extension of Period to Use the Balance of Funds Approved Under Board Resolution No. 883, S. 2011 to Defray Cost of Operating Expenses Relative to the Full Implementation of the 2013 CLUP Zero Backlog Program Not Covered or Funded by the General Appropriations Act

WHEREAS, Section 9 of Executive Order No. 648, Series of 1981, as amended by Executive Order No. 90, Series of 1986, authorizes the HLURB to directly utilize its income generated from fees, fines, charges and other collections in the performance of its functions to defray operating expenses and provide allowances to its personnel;


WHEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the request for extension of period to utilize the balance of funds approved under Board Resolution No. 883, S. 2011 in the amount of approximately Seven Million Eight Hundred Sixty Five Thousand Pesos (P7,865,000.00) to defray the cost of operating expenses relative to the full implementation of the 2013 Zero Backlog Program not covered or funded by the general appropriations act be, as it is hereby, **APPROVED**.




