WHEREAS, the Board finds sufficient legal basis to support the above Resolution of the HLURB Executive Committee;

WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that Executive Committee Resolution No. 004, Series of 2013, approving the 2013-2016 Collective Negotiation Agreement between the Association of HLURB Employees for Advancement and Development and the Housing & Land Use Regulatory Board be, as it is hereby, **RATIFIED**.




