**APPROVING THE COMPREHENSIVE LAND USE PLAN AND
ZONING ORDINANCE OF THE CITY OF ANGELES
2010-2020**

WHEREAS, the Board is empowered under Letter of Instruction No. 729, Executive Order (EO) No. 648 Series of 1981 as amended by EO No. 90 Series of 1986, Republic Act No. 7279, and the Local Government Code, as implemented by Executive Order No. 72 Series of 1991 to review and ratify land use plans of Independent Component and Highly Urbanized Cities and Metro Manila local government units to ensure their compliance with national standards;

WHEREAS, Angeles City has completed the updating and revision of its Comprehensive Land Use Plan and Zoning Ordinance through the City Development Council and the City Planning and Development Office;

WHEREAS, the Comprehensive Land Use Plan was approved and enacted by the Sangguniang Panlungsod through City Ordinance No. 317 S-2012 titled "*An Ordinance Adopting the Comprehensive Land Use Plan (CLUP) and Zoning Ordinance 2010-2020 of Angeles City*";


WHEREAS, the Regional Land Use Committee reviewed and favorably endorsed the adoption and approval by the City of Angeles of the CLUP and Zoning Ordinance through RLUC Resolution No. 1 Series of 2011 titled "*Endorsing to the Sangguniang Panlungsod (SP) of Angeles City for Enactment into an Ordinance the Comprehensive Land Use Plan (CLUP) of Angeles City, 2010-2020*"


WHEREAS, the Regional Land Use Committee further endorsed the said plan documents through RLUC Resolution No. 1 Series of 2013 titled "*Endorsing the Disaster Risk Reduction (DRR) and Climate Change Adaptation (CCA) Enhanced Comprehensive Land Use Plan (CLUP) 2010-2020 and Zoning Ordinance of Angeles City*";

WHEREAS, after a review of the submitted plan documents pursuant to the Review and Approval Process provided under HLURB Board Resolution No. 908 Series of 2013, "Approving the 2013 Enhanced Comprehensive Land Use Plan Guidebook Volume 1," the Board finds the Comprehensive Land Use Plan and Zoning Ordinance of Angeles City in compliance with national standards and guidelines on Comprehensive Land Use Plan and Zoning Ordinance formulation;


WHEREFORE, be it RESOLVED as it is hereby RESOLVED that the COMPREHENSIVE LAND USE PLAN and ZONING ORDINANCE OF ANGELES CITY, 2010-2020 adopted and enacted through City Ordinance No. 317, S-2012 be, as the same are hereby APPROVED.


