**APPROVING THE PROVINCIAL PHYSICAL
FRAMEWORK PLAN (PPFP) OF THE PROVINCE OF
OCCIDENTAL MINDORO 2014-2023**

WHEREAS, the Board is empowered under Letter of Instruction No. 729, Executive Order No. 648 Series of 1981 as amended by Executive Order No. 90 Series of 1986, Republic Act No. 7279, and Republic Act No. 7160, the Local Government Code as implemented by Executive Order No. 72 Series of 1991 to review and ratify the Provincial Physical Framework Plan of Provinces;

WHEREAS, the Province of Occidental Mindoro has completed the formulation of its Provincial Physical Framework Plan through the Provincial Development Council and the Provincial Planning and Development Office;

WHEREAS, the Provincial Physical Framework Plan, which embodied the desired development thrusts of the province shall guide and set the direction of development and provide guidance to its component local government units in the preparation of their respective Comprehensive Land Use Plans;

WHEREAS, the Regional Land Use Committee, an inter-agency committee, reviewed the said PPFP and recommended its adoption and approval by the Sangguniang Panlalawigan through Resolution No. 01 Series of 2015;

WHEREAS, the combined Provincial Development Plan and Provincial Physical Framework Plan of the Province was approved by the Sangguniang Panlalawigan through Resolution No. 139, Series of 2015 titled *Ratifying the Disaster Risk Reduction/Climate Change Adaptation (DRR/CCA) Enhanced Provincial Development and Physical Framework Plan (PDPFP) 2014-2023 of Occidental Mindoro*;

WHEREAS, the Province of Occidental Mindoro has complied with the prescribed procedural and documentary requirements in the formulation of Provincial Physical Framework Plans;
