



**CONTRACT FOR THE SUPPLY AND DELIVERY OF
BRANDED LAPTOP AND DESTOP COMPUTERS**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this JUN 02 day of 2015, 2015, in QUEZON CITY
Metro Manila, by and between:

 The **HOUSING AND LAND USE REGULATORY BOARD**, a national government agency organized and existing by virtue of Philippine laws, with principal office at Kalayaan Avenue corner Mayaman St., Diliman, Quezon City, herein represented by its NCR Regional Director II, **ALFREDO GIL M. TAN II**, herein referred to as the "ENTITY".

 **DCI INTERNATIONAL I.T. SOLUTIONS & SERVICES CORPORATION**, a corporation duly organized and existing by virtue of Philippine laws, with office address Unit 3A COMTAL Building L1 D1 Victoria's Place, C. Raymundo Avenue, Brgy. Caniogan, Pasig City, herein represented by its Account Manager, **MICHELLE T. FELIPE**, and hereinafter referred to as the "SUPPLIER".

WHEREAS, the ENTITY invited Bids for Project No. ITB-ENCR-15-002: PROCUREMENT OF ELEVEN (11) BRANDED LAPTOP AND EIGHTEEN (18) BRANDED DESKTOP COMPUTERS and has accepted a Bid by the SUPPLIER for the supply of those goods in the sum of **One Million One Hundred Thirty One Thousand Seven Hundred Twenty Pesos Only (₱1,131,720.00)** (hereinafter called the "Contract Price").

WITNESSETH:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) Notice of Award.

3. In consideration of the payments to be made by the **ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **ENTITY** to provide the goods and services to remedy defects therein in conformity in all respects with the provisions of the Contract;

4. The **ENTITY** hereby covenants to pay to the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;

5. The contract price covers the costs of all deliverable items and services and includes all applicable taxes and duties in the Philippines, costs of importation, transportation and delivery to the location specified;

6. All other terms, conditions and stipulations accompanying this Contract together with all the proposals and all mandatory provisions of the Revised Implementing Rules and Regulations of RA 9184 shall form an integral part of the contract between the parties hereto;

7. Both the **ENTITY** and **SUPPLIER** and all parties who lawfully succeed to their rights and responsibilities are bound by this Contract and shall terminate upon the satisfactory fulfillment of all terms and conditions embodied therein; and

8. Any and all actions/suits pertaining to this Contract shall be brought within the exclusive jurisdiction of Quezon City, Metro Manila.




