

**HLURB-ITB-CO-12-004**

**INVITATION TO BID**

**SUPPLY AND DELIVERY OF ONE (1) UNIT OF MOTOR VEHICLE**

1. The Housing and Land Use Regulatory Board (HLURB), through the General Appropriations Act of 2012 intends to apply the sum of Nine Hundred Thousand Pesos (P900,000.00), inclusive of 12% VAT, being the Approved Budget for the Contract (ABC) for the supply and delivery of one (1) unit of motor vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening. The technical description of the motor vehicle is as follows:

“Any four-wheel passenger van or pick-up type vehicle with not less than four (4) doors and an engine displacement not exceeding 2200 cc for gasoline or 3000 cc for diesel. Allowable options/accessories are AM/FM stereo-cassette/CD player, airconditioning unit and magwheels.”

2. The HLURB now invites bids for supply and delivery of one (1) unit of motor vehicle. Delivery of the Goods is required within thirty (30) days from receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date and submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested bidders may obtain further information at the address given below starting October 3, 2012 from 8:30 a.m. to 4:00 p.m. A complete set of Bidding Documents may be purchased by interested Bidders on October 3, 2012 to October 23, 2012 upon payment of a non-refundable fee of One Thousand Pesos (P1,000.00).

6. Bids must be delivered to the address below on or before October 23, 2012 at 10:00 a.m. All Bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulations of RA 9184.
7. Bid opening shall be on October 23, 2012 at 10:30 a.m. at the HLURB Boardroom, HLURB Building, Kalayaan Ave. cor. Mayaman St., Diliman, Quezon City. Late bids shall not be accepted.
8. The HLURB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
