The Housing and Land Use Regulatory Board (HLURB) is accepting offers from interested buyers by way of sealed bid for the following vehicles by LOT on "AS IS WHERE IS BASIS", to wit:

Bidders shall accomplish the Bid Tender in at least three (3) copies preferably typewritten indicating the following:

- 1) The description of the items/lots with the corresponding bid offer clearly indicated in figures and in words;
- 2) The name and signature of the bidder;
- 3) The business or residence address of the bidder; and
- 4) The business license number or Residence Certificate number of the bidder.


Bid Tender should be placed in an envelope properly sealed and addressed to the Chairman, Bids & Awards Committee. The bidders shall submit bid tenders for different lots in separate envelopes. Erasures or interlineations should be avoided or duly initialed by the bidder.

Bids must be delivered to Ms. Imelda E. Lariosa, Officer-in-Charge, General Services Section of the Housing and Land Use Regulatory Board (HLURB) located at HLURB Building, Ground Floor, Kalayaan Avenue corner Mayaman St., Diliman, Quezon City on or before 9:00 of July 18, 2014, Friday or you may call at Telephone Number 924-33-72 for further details. Prior to the date of bidding, vehicles can be inspected at HLURB's parking area from 8:00am 4:00pm, Monday to Friday (except holidays).

Opening of sealed bids shall be on July 18, 2014 at exactly 10:30 a.m. at HLURB Boardroom. Late bidders shall not be accepted. Interested bidders are required to register with the Administrative Division-General Services Section.

The bidder shall enclose in a sealed envelope his bid together with his minimum bid bond equivalent to ten percent (10%) of the minimum bid price set by the government. Bid bond should be in the form of cash, manager's check issued by a reputable bank payable to the HLURB. The bidder's bond will be returned to the non-winning bidders right after the bidding. Full payment shall be made by the winning bidder within five (5) working days from the date of the Notice of Award. The 10% advance payment shall be forfeited in favor of the government, in case the full payment was not made within the prescribed period and the vehicles shall be negotiated with the second highest bidder.

HLURB reserves the right to reject any or all bids, to waive any informality therein and to accept any or all bids that may be considered advantageous to the government.
