The bidder shall enclose in a sealed envelope his bid together with his minimum bid bond equivalent to ten percent (10%) of the minimum bid price set by the government. Bid bond should be in the form of cash, manager's check issued by a reputable bank payable to the HLURB. The bidder's bond will be returned to the non-winning bidders right after the bidding. Full payment shall be made by the winning bidder within five (5) working days from the date of the Notice of Award. The 10% advance payment shall be forfeited in favor of the government, in case the full payment was not made within the prescribed period and the vehicles shall be negotiated with the second highest bidder.
