



RE-INVITATION TO BID

Purchase of Two (2) units Brand New Service Vehicle

1. The *Housing and Land Use Regulatory Board*, through its Service Income, intends to apply the sum of *Two Million Four hundred Thousand Pesos (2,400,000.00)*, inclusive of 12% VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for purchase of two (2) units brand new service vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The HLURB now invites bids for purchase of two (2) units brand new service vehicle. Delivery of the Goods is required within thirty (30) days from receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date and submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. The HLURB will hold Pre-Bid Conference on June 13, 2014 at 10:00 AM at the HLURB, 3rd floor, dupoint building, Velez – Akut Street, Cagayan de Oro City, which shall be open only to all interested parties who have purchased the bidding documents.
5. Interested bidders may obtain further information at the address given below starting June 3, 2014 from 8:00 a.m. to 5:00 p.m. A complete set of Bidding Documents may be purchased by interested bidders on June 4, 2014 to June 19, 2014 upon payments of a non-refundable fee of Five Thousand Pesos (5,000.00).
6. Bids must be delivered to the address below on or before June 19, 2014 at 10:00 a.m. All Bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulation of RA 9184.


