INVITATION TO BID
SUPPLY AND DELIVERY OF TWO (2) UNITS OF MOTOR VEHICLE

1. The Housing and Land Use Regulatory Board - Northern Tagalog Region (HLURB-NTR), pursuant to the General Appropriation Act of 2014 and based on its internal budget allocation, intends to apply the sum of Two Million Four Hundred Thousand Pesos (Php2,400,000.00), in Philippine currency, inclusive of 12% VAT, being the Approved Budget for the Contract (ABC) for the supply and delivery of two (2) units of motor vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The HLURB-NTR now invites bids for supply and delivery of two (2) units of motor vehicle. Delivery of the Goods is required within thirty (30) days from receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date and submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. The HLURB-NTR will hold a Pre-Bid Conference on April 7, 2014 at 10:00 am at the HLURB-NTR Conference Room, 3/F Insular Life Building, Dolores, City of San Fernando, Pampanga, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Interested bidders may obtain further information at the address given below starting March 28, 2014 from 8:30 a.m. to 4:00 p.m. A complete set of Bidding Documents may be acquired by interested Bidders on March 28, 2014 to April 21, 2014 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (Php 2,000.00).
7. Bids must be delivered to the address below on or before April 21, 2014 at 1:00 p.m. All Bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulations of RA 9184.
8. Bid opening shall be on April 21, 2014 at 1:30 p.m. at the HLURB-NTR Conference Room, 3/F Insular Life Building, Dolores, City of San Fernando, Pampanga. Late bids shall not be accepted.
9. The HLURB-NTR reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
