



**INVITATION TO BID**  
**HLURB-ITB-SMR-14-004**  
**SUPPLY AND DELIVERY OF TWO (2) UNITS OF MOTOR VEHICLE**

1. The Housing and Land Use Regulatory Board (HLURB), through the General Appropriations Act of 2014, intends to apply the sum of Two Million Four Hundred Thousand Pesos (P2,400,000.00), inclusive of 12% VAT and subject to creditable withholding tax, being the Approved Budget for the Contract (ABC) for the hereunder supply and delivery of two (2) units of motor vehicle:

Quantity	Unit of Issue	DESCRIPTION
1	unit	Pick Up (4x2 MT)
1	unit	Commuter Van (2.5 Diesel MT)


Bids received in excess of the ABC per Lot shall be automatically rejected at bid opening.

2. The HLURB now invites bids for supply and delivery of the two (2) above mentioned motor vehicles. Delivery of the Goods is required within thirty (30) days from receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date and submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

5. The HLURB will hold a Pre-Bid Conference on June 5, 2014 at 10:00 a.m. at the HLURB SMR Conference Room, 2/F Cam Building, Monteverde St., Davao City, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Interested bidders may obtain further information at the address given below starting May 28, 2014 from 8:30 a.m. to 4:00 p.m. A complete set of Bidding Documents may be purchased by interested Bidders on May 29, 2014 to June 16, 2014 upon payment of a non-refundable fee of Two Thousand Five Hundred Pesos (P2,500.00).
7. Bids must be delivered to the address below on or before 8:30a.m. of June 17, 2014. All Bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulations of RA 9184.
8. Opening of Bids shall be on June 17, 2014 at 9:00a.m. at the HLURB SMR Conference Room, 2/F CAM Building, Monteverde Street, Davao City. Late bids shall not be accepted.
9. The HLURB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
