

**INVITATION TO BID FOR THE PROCUREMENT OF
BRANDED LAPTOPS AND DESKTOPS**

The Housing and Land Use Regulatory Board (HLURB) intends to apply the sum of **Three Million Two Hundred Forty Thousand Pesos (P3,240,000.00)** for **Central Office** being the Total Approved Budget for the Contract (ABC).

Bids received for each lot in excess of the corresponding ABC will be automatically rejected at bid opening. All bids shall be inclusive of all prevailing taxes and all other charges.

The HLURB now invites all proponents with at least five (5) years of continuous business operation as legitimate laptops and desktops suppliers to apply for eligibility and to bid for the contract for laptops and desktops. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, at least two (2) contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information at the address given below starting February 16, 2015 from 8:30 am to 4:00 pm. A complete set of Bidding Documents may be purchased by interested Bidders on February 16 to March 9, 2015 upon payment of a non-refundable fee of Five Thousand Pesos (P5,000.00).

The HLURB will hold a Pre-Bid Conference on February 24, 2015, 10:00 am, at the HLURB Boardroom, HLURB Building, Kalayaan Ave. cor. Mayaman St., Diliman, Quezon City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before 10:00 am of March 10, 2015. All Bids must be accompanied by a bid security in accordance with Section 27 of the Revised Implementing Rules and Regulations of RA 9184.

Bid opening shall be on March 10, 2015, 10:30 am at the HLURB Boardroom, HLURB Building, Kalayaan Ave. cor. Mayaman St., Diliman, Quezon City. Late bids shall not be accepted.

The HLURB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
