**INVITATION TO BID FOR THE PROCUREMENT OF**  
**BRANDED LAPTOPS AND DESKSTOP**

The Housing and Land Use Regulatory Board-Southern Mindanao Region (HLURB-SMR), intends to apply the sum of Eight Hundred Thousand Pesos (P800,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply and delivery of the following:

Bids received for each lot in excess of the excess of the corresponding ABC will be automatically rejected at bid opening. All bids shall be inclusive of all prevailing taxes and all other charges.

The HLURB-SMR now invites all proponents with at least five (5) years of continuous business operation as legitimate laptops and desktops suppliers to apply for eligibility and to bid for the contract for laptops and desktops. Bidders should have at least completed two (2) contracts similar to this projects within a period of two (2) years from the date of receipt of their bids.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information at the address given below starting April 6, 2015 from 8:30 AM to 4:30 PM. A complete set of Bidding Documents may be purchased by interested bidders from April 6 to April 14, 2015 upon payment of non-refundable of One Thousand Pesos Only (P1,000.00).


