SUBJECT : **RESOLUTION NO. R-939, S. 2016, APPROVING
THE PROVINCIAL DEVELOPMENT AND
PHYSICAL FRAMEWORK PLAN OF THE
PROVINCE OF PALAWAN, 2014-2023**

Quoted hereunder is the subject resolution, approved by the Board of Commissioners on 12 October 2016:

WHEREAS, the Board is empowered under Letter of Instruction No. 729, Executive Order No. 648 Series of 1981 as amended by Executive Order No. 90 Series of 1986, Republic Act No. 7279, and Republic Act 7160, the Local Government Code as implemented by Executive Order No. 72 Series of 1991 to review and ratify the Provincial Physical Framework Plan of Provinces;

WHEREAS, the Provincial Development and Physical Framework Plan embodies the desired development thrusts of the province, guides and sets the direction of development and provides guidance to its component local government units in the preparation of their respective Comprehensive Land Use Plans;

WHEREAS, the Province of Palawan has mainstreamed climate change and disaster risk reduction in its Provincial Development and Physical Framework Plan;

WHEREAS, the Regional Land Use Committee, an inter-agency committee with HLURB as a member reviewed the said PDPFP and recommended its approval/adoption by the province through RLUC Resolution No. 02, Series of 2015;

WHEREAS, the Provincial Development Council favorably endorsed for approval the PDPFP by the province through Provincial Development Council Resolution Number 10 Series of 2014 titled *A Resolution Approving and Favorably endorsing to the*

Sangguniang Panlalawigan the DRR-CCA Enhanced Provincial Development and Physical Framework Plan, CY 2014-2023;

WHEREAS, the Sangguniang Panlalawigan of the Province of Palawan approved the PDPFP through Resolution No. 11678 Series of 2014 titled *Approving the Provincial Development and Physical Framework Plan (PDPFP) Volumes 1-3 of the Province of Palawan for CY 2014-2023;*

WHEREFORE, be it **RESOLVED** that the Provincial Development and Physical Framework Plan, 2014-2023 of the Province of Palawan be, as the same is hereby **APPROVED**.

FURTHER RESOLVED, that the Provincial Government of Palawan shall ensure the integration of the province's land use development policies and the mainstreaming of climate change and disaster risk reduction in the Comprehensive Land Use Plans of the province's component cities and municipalities.
