Quoted hereunder is the subject resolution, Approving the Comprehensive Land Use Plan of Iligan City, 2013-2022, approved by the Board of Commissioners on 01 August 2018:

**WHEREAS**, the Board is empowered under Letter of Instruction No. 729, Executive Order (EO) No. 648 Series of 1981 as amended by EO No. 90 Series of 1986, Republic Act No. 7279, and the Local Government Code, as implemented by Executive Order No. 72 Series of 1991 to review and ratify land use plans of Independent Component and Highly Urbanized Cities and Metro Manila local government units to ensure their compliance with national standards;

**WHEREAS**, Iligan City has completed the updating and revision of its Comprehensive Land Use Plan (CLUP) and Zoning Ordinance (ZO) through the City Development Council and the City Planning and Development Office;

**WHEREAS**, the Comprehensive Land Use Plan, 2013-2022 was approved by the Sangguniang Panlungsod through Resolution No. 14-1140 Series of 2014 that adopted and approved City Ordinance No. 14-6233 titled " An Ordinance Approving the Comprehensive Land Use Plan (CLUP) of Iligan City, Volume 1";

**WHEREAS**, the Regional Land Use Committee-Region X endorsed for adoption by the city of Iligan, the disaster risk reduction and climate change adaption-enhanced CLUP and ZO of Iligan City, through RLUC Resolution No. 1 Series of 2013 titled "Endorsing the Disaster Risk Reduction (DRR) and Climate Change Adaption (CCA) –

Enhanced Comprehensive Land Use Plan (CLUP), 2013-2022 and Zoning Ordinance (ZO) of Iligan City”;

**WHEREAS**, after the review of the submitted plan documents pursuant to the Review and Approval Process provided under HLURB Board Resolution No. 908 Series of 2013, the Board finds the Comprehensive Land Use Plan and Zoning Ordinance of Iligan City in compliance with national standards and guidelines on Comprehensive Land Use Plan and Zoning Ordinance formulation;

**WHEREFORE**, be it **RESOLVED** as it is hereby **RESOLVED** that the **COMPREHENSIVE LAND USE PLAN OF ILIGAN CITY, 2013-2022** adopted and approved by the Sangguniang Panlungsod through Resolution 14-1140 Series of 2014 adopting and approving City Ordinance No. 14-6233, “An Ordinance Approving the Comprehensive Land Use Plan (CLUP) of Iligan City, Volume 1” be, as the same is hereby **APPROVED**.
