Quoted hereunder is the subject resolution, *Approving the DRR-CCA Enhanced Provincial Development and Physical Framework Plan (PDPFP) of the Province of Pangasinan, 2018-2027*, approved by the Board of Commissioners on 21 October 2019:

**WHEREAS**, the Board is empowered under Letter of Instruction No. 729, Republic Act No. 7279 and Republic Act 7160, the Local Government Code as implemented by Executive Order No. 72 Series of 1991 to review and ratify the Provincial Physical Framework Plan of Provinces;

**WHEREAS**, the Provincial Development and Physical Framework Plan (PDPFP) embodied the desired development thrusts of the province, guide and set the direction of development and provide guidance to its component local government units in the preparation of their respective Comprehensive Land Use Plans;

**WHEREAS**, the Province of Pangasinan has mainstreamed climate change and disaster risk reduction in the Provincial Development and Physical Framework Plan;

**WHEREAS**, the Regional Land Use Committee, an inter-agency committee reviewed the said PDPFP and recommended its approval/adoption by the province through RLUC-1 Resolution No. 01, Series of 2018 titled "Endorsing the Provincial Development and Physical Framework Plan (PDPFP) of the Province of Pangasinan to the Sangguniang Panlalawigan for Approval";

**WHEREAS**, the Provincial Development Council (PDC) favorably endorsed for approval the PDPFP of the province through PDC Resolution No. 04, S. 2018;


**WHEREAS**, the Province of Pangasinan Sangguniang Panlalawigan approved the PDPFP through Provincial Resolution No. 92-2019 titled "Approving the Provincial Development and Physical Framework Plan (PDPFP), of the Province of Pangasinan for Calendar Year 2018-2027 and its Accompanying Document, the Provincial Investment Program for CY 2018-2027";

**WHEREFORE**, be it **RESOLVED** as it is hereby **RESOLVED** that the **CCA-DRR ENHANCED PROVINCIAL DEVELOPMENT AND PHYSICAL FRAMEWORK PLAN, 2018-2027** of the **PROVINCE OF PANGASINAN** be **APPROVED**, as the same is hereby **APPROVED**.

**FURTHER RESOLVED**, that the Provincial Government of Pangasinan shall ensure the integration of the province's land use development policies and the mainstreaming of climate change and disaster risk reduction in the Comprehensive Land Use Plans of the province's component cities and municipalities.
